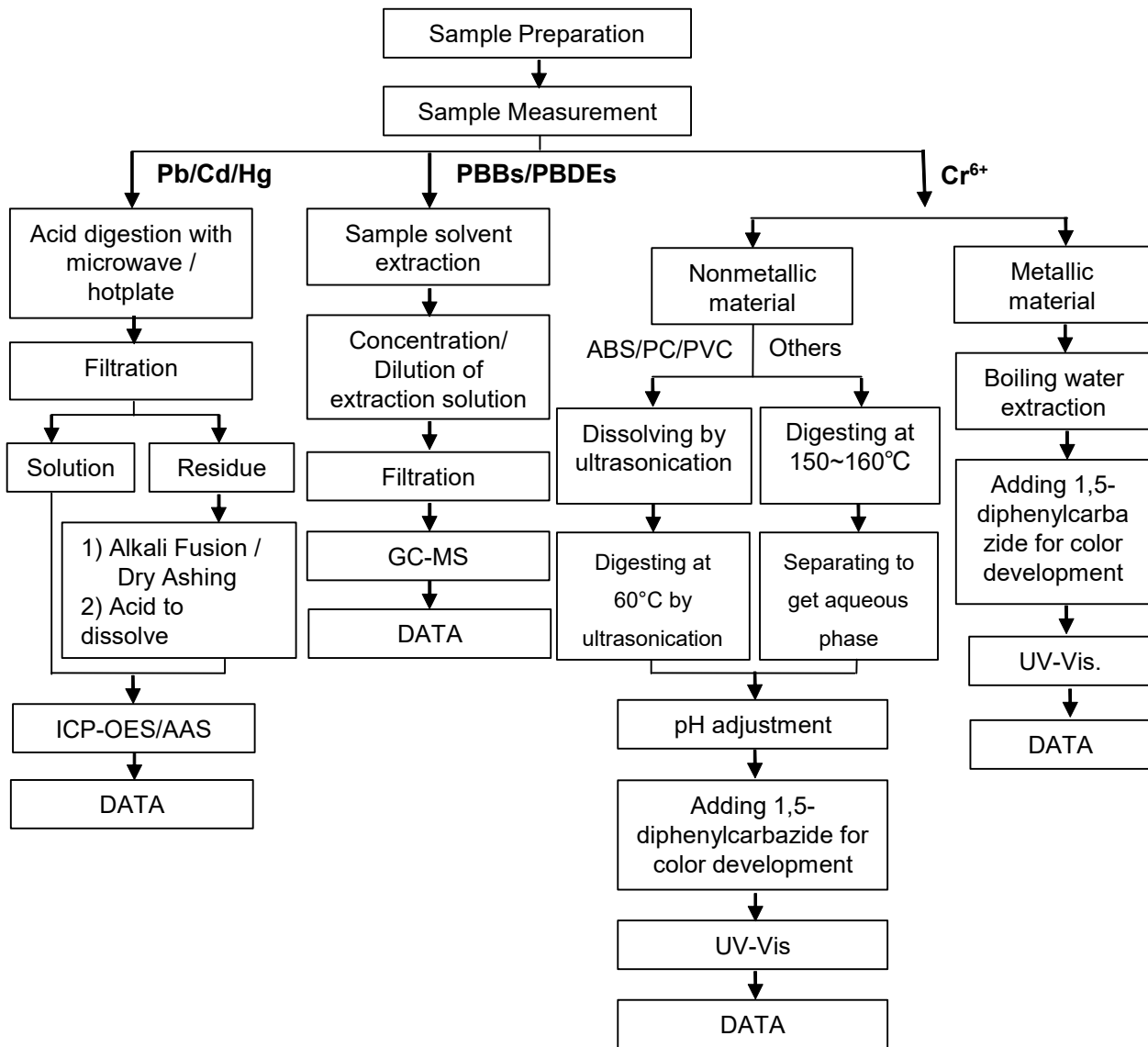

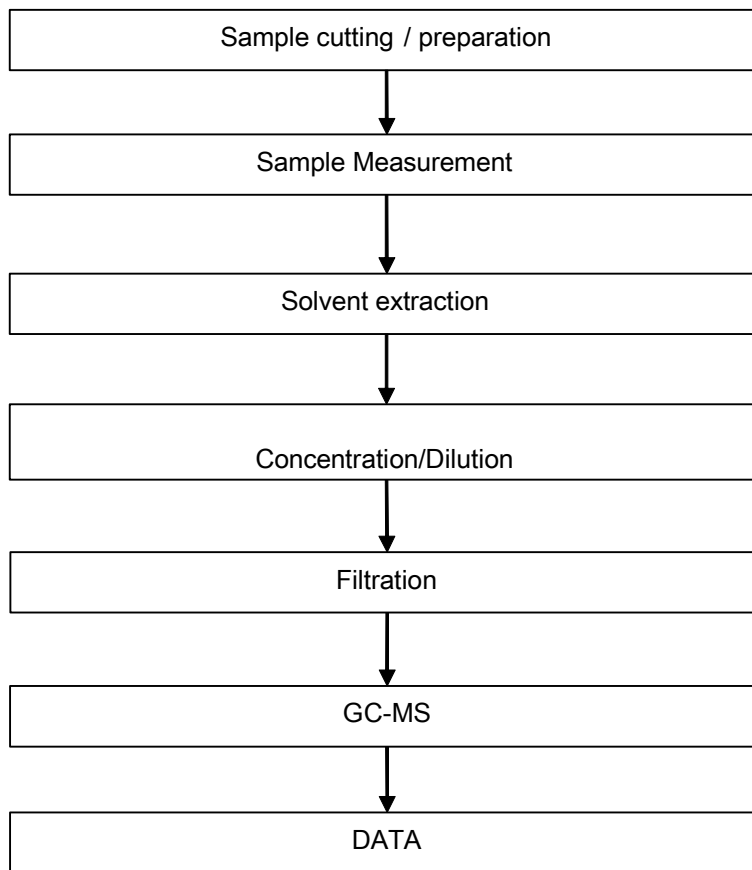

Phthalates Testing Flow Chart

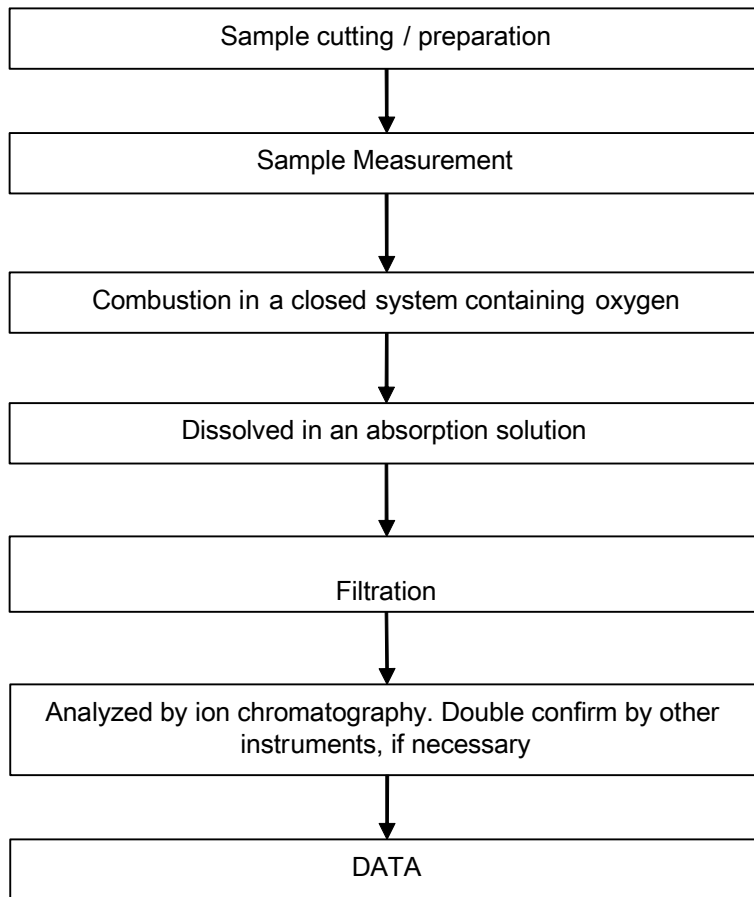

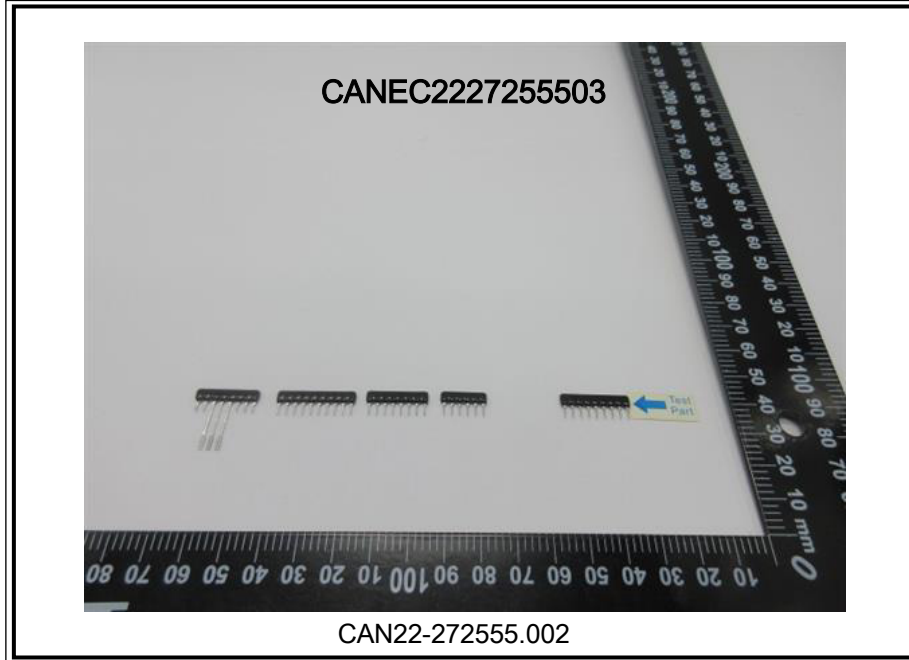
Halogen Testing Flow Chart
